Sidewalk Ramps



A request was made to the Baltimore County Bureau of Traffic Engineering and Transportation Planning to have sidewalk ramps placed at the following corners Carlson Lane at Stevenswood Road; and Carlson Lane at Kenjac Road; and Edcrest Road at Lauri Road; and Edcrest Road at Kenjac Road. The response stated that curb modifications can be considered on streets where people using assistance devices to aid them when crossing streets near their homes.

Tree Storm Damage



A request was made to the Emergency Preparedness Department of Baltimore County to provide information concerning the storm damage procedures when a tree falls on Your Property

At one time or another, just about every homeowner or someone the homeowner knows has had a tree fall due to wind, a storm or winter weather. The question that everyone wants to know is, "Will my homeowners insurance pay for the damage and who do I call for repairs?" The answers depend on the terms of your homeowners'


policy. Each homeowner should look at their homeowners' policy or talk with a representative from their insurance company to find out what the policy specifically covers and doesn't cover. Homeowners should also be sure to know what the policy deductible is, and any dollar limits on the amount of damage the policy will cover. Although the terms of your actual policy will determine if the damage you have incurred is covered, generally many homeowners' policies will:

- •provide coverage for damage to your home and the contents of your home if a tree (even if it is your neighbor's tree) falls on your home or other insured structure, such as a fence or a detached garage
- •provide some coverage for the cost of tree removal. Many policies pay a limited amount (usually between \$500 and \$1,000) to remove the tree(s) from your property, whether the tree damages an insured structure or just falls in your yard. The amount paid for tree removal is typically based on the event and not the number of trees that fall. This means that you will receive the same amount of money whether just one tree falls, or if 10 trees fall.
- •provide some coverage for damage to your trees, shrubs or plants in certain very limited circumstances, such as fire, lightning or vandalism; damage from snow, ice or wind is generally not covered.
- •not provide coverage for damage to your car if the tree falls on it.

Additionally, your local municipality may arrange for debris removal after a major storm that affects a large area.

Any needed repairs are the responsibility of the homeowner, with no recommended list of companies providing repair services.

Owings Mills Boulevard Extension Phase II



Phase II of the Owings Mills Boulevard Extension will connect Winards Road to Liberty Road at Live Oak Road. The Kings Park signage will be set back from its current location because of the widening of Liberty Road at that location. Phase II is currently in the Design Phase with work scheduled to begin in September, 2013. Also, the final half-mile of Dolfield Boulevard connecting Reisterstown Road to Lakeside Boulevard in Owings Mills is open to traffic. The final phase of the Boulevard, which runs from Interstate-795 to Reisterstown Road, began in July of 2012 and was finished almost a year ahead of schedule.

RECYCLE-RECYCLE-RECYCLE

In 2012, Baltimore County residents recycled more of their household trash than in the history of the County's more than 20-year history of recycling. During the calendar year of 2012, more than 52,500 tons of material was collected for recycling from Baltimore County residents. This is an all-time County record, and approximately 1,200 tons more than what was collected for recycling in 2011.

By diverting these 52,500 tons of material from the waste stream, the County saved nearly \$3 million in avoided disposal costs of about \$57 per ton. The county collected 314,000 tons of residential trash last year as well, so there is room for improvement. The Catonsville/Oella area has one of the highest curbside recycling rates in the county, 31.7 percent in December 2012. The County Executive congratulated those residents, and thanked them for their recycling efforts, which have shown improvement over the past year from an average of 24.2 percent by weight in 2011 to an average of 27.6 percent by weight in 2012.

We know the Stevenswood Community can improve on the number of households that recycle and you know it's for the benefit of all of us. Let that Recycle Collection Truck stop at every house throughout the remainder of 2013 and into the coming years. Thank you to all who find the time to participate.

In an effort to increase recycling participation the SIA Executive Board has approved the following promotion.

- 1. A \$ 15.00 credit to the 2014 \$ 25.00 membership application for any household who:
 - a. Purchases at least a 14 gal. recycle bin/container for recycling purposes; and
 - b. Provides the proof of purchase attached to their 2014 Membership Application; and
 - c. Provides the \$ 10.00 reduced Membership Fee with their 2014 Membership Application
- 2. The promotion period begins October 1, 2013 and ends January 31, 2013.

ACA AFFORDABLE CARE ACT

Maryland Health Connection, the state-based health insurance marketplace operated by the Maryland Health Benefit Exchange, provides customer call center support in Baltimore for residents and small employers statewide. Representatives, including bi-lingual staff, guides Maryland residents and small employers through their health coverage options, explain financial assistance options available including federal tax credits and cost-sharing reductions, and answers customer service questions.

The call center, staffed with 125 representatives, will aid residents in selecting health insurance plans through Maryland Health Connection. The call center is operational seven days a week, during the open enrollment period, which ends on March 31, 2014.

A translation help line provides translation services in 200 languages for individuals who require additional assistance and TTY service is provided for the hearing impaired. Representatives are available during open enrollment (Oct. 1, 2013 through March 31, 2014) Monday through Friday from 8 a.m. to 8 p.m., Saturday from 8 a.m. to 6 p.m., and Sunday from 9 a.m. to 2 p.m.

The call center is located at 1 South St. in Baltimore City. The toll-free phone number is 855-642(MHC)-8572, and 1-855-642(MHC)-8573 for TTY service. The Maryland Health Benefit Exchange is working with other state agencies, including the Department of Health and Mental Hygiene and the Department of Human Resources, as well as consumer assistance organizations and insurance companies to ensure the appropriate hand-off procedures are implemented for transfers to other agencies and organizations in the event consumers require help with other matters. It also will employ state-of-the-art technologies for call distribution, tracking, and reporting, online knowledge database and workforce management.

Following open enrollment in March 2014, the call center will be open during normal business hours to serve Maryland residents, Monday through Friday from 8 a.m. to 8 p.m., and Saturday from 8 a.m. to noon.

An estimated 14 percent of Maryland's population of 5.8 million, or 800,000, is currently uninsured. The state-based insurance marketplace will provide access to financial assistance to individuals and families to reduce the cost of monthly insurance premiums and out-of-pocket costs such as copays and deductibles through Advance Premium Tax Credits and Cost Sharing Reductions. An estimated 180,000 individuals are expected to enroll in qualified health plans (QHPs) during the first year of Maryland Health Connection's operation. Statewide, nearly 100,000 Marylanders are expected to become newly eligible for Medicaid as a result of the expansion of Medicaid provided by the Affordable Care Act. Individuals who enroll through Maryland Health Connection before Dec. 18 will have coverage beginning in Jan.




Election of SIA Officers



In accordance with the by-laws of SIA, all officers serve a three year term. All terms are set to expire at the January 14, 2015 General Meeting. In accordance with general consensus the existing officers of the Stevenswood Improvement Association are President, 3 Vice Presidents, Treasurer, and Secretary. A nominating committee (5 members) is scheduled to be elected at the General Meeting of July 9, 2014. This committee shall notify the membership of the nominee candidates in October, 2014. What can 1 do as a Stevenswood resident to make our community an ideal place to live?

A: Keep your house and yard properly maintained; and donate your old unused vehicles to charity; and put your trash in rodent proof containers with tight fitting lids; and look out for your neighbors.

Is there a community newsletter? If you don't pay membership dues are you entitled to a newsletter?

A: There is a community newsletter, "The Stevenswood Connection". Each edition is scheduled for publication just prior to each General Meeting, (which are held in January, April, July, and October). The initial edition scheduled for January of each year is mailed to all 205 households in the community. The remaining 3 editions are distributed via block captains, to all 205 households in the community.

What are the new speed camera locations?

Towson, Maryland (May 29, 2013) – The Baltimore County Police Department has approved installation of speed cameras in 13 additional school zones where data and community input show that speeding is a problem.

Construction of the camera pads has begun at the new locations. Police advise motorists traveling through these school zones to reduce their speeds to the legal limit now.

Who do I call if a vehicle is parked in the wrong direction on the street?

Call Baltimore County Police non-emergency number, 410-887-2222, if the vehicle is not parked with the passenger side next to the curb. County Police are now issuing tickets for this violation

Who do I call if my neighbors do not shovel their sidewalk after a snowstorm?

A. Call Baltimore County Police non-emergency number, 410-887-2222, if the snow is not removed within 24 hours after the fall of any snow. The police can give a warning or a \$25 fine for each failure to remove the snow and an additional \$25 for each day the obstruction continues.

A. No, this is a Baltimore County Code violation and should be reported.

My neighbor frequently works on cars in his driveway and in front of his house. Is this allowed?

A. No, this is a Baltimore County Code violation and should be reported.

With outside events, involving many people and loud music late into the night; What can I do if I feel the noise level is too high and causing a disturbance?

A. You are advised to call 911 and let the police handle the situation

My neighbor's dog barks excessively, day and well into the night. What can I do?

A. You are advised to call 911 and let the police handle the situation

How and when do I pay my membership dues?

A. Membership dues are due on January 1 of each year. The initial Newsletter of the year will contain information about how to pay your dues. You can also provide your dues to your block captain or an officer of the association.




